CHAPTER 1

GENERAL PROVISIONS, FULL AND ABBREVIATED NAME

1.1. Public Association "Professional Dance League" (hereinafter referred to as the PA "Professional Dance League") is a voluntary, independent, non-profit public organization created on the basis of a free association of individuals, community of professional interests of specialists, coaches, athletes, dancers and other persons engaged in the development and popularization of various types of dance art and dance sports in the Republic of Belarus. The PA "Professional Dance League" has a sports, educational, cultural, sports and mass nature of its activities.

1.2. The PA "Professional Dance League" carries out its activities in accordance with the Constitution of the Republic of Belarus, the Civil Code of the Republic of Belarus, the Law of the Republic of Belarus "On Public Associations", other acts of legislation of the Republic of Belarus and this Charter.

1.3. The PA "Professional Dance League" acquires the rights of a legal entity from the date of its state registration, enjoys the rights and fulfills the obligations provided for by the legislation of the Republic of Belarus for public associations.

1.4. The activities of the PA "Professional Dance League" are based on the principles of legality, voluntariness, independence, equality and publicity.

1.5. The PA "Professional Dance League" may participate in the creation of international public associations, unions (amalgamations) of public associations on the territory of the Republic of Belarus and foreign states join international public associations, unions (amalgamations) of public associations established on the territory of both the Republic of Belarus and foreign states. The PA "Professional Dance League" may maintain direct international contacts and relations, conclude relevant agreements and carry out other activities that do not contradict the legislation of the Republic of Belarus, including international treaties of the Republic of Belarus.

1.6. The PA "Professional Dance League" carries out its activities in close cooperation with government bodies in the fields of education, culture and sports of the Republic of Belarus.

1.7. The PA "Professional Dance League" has an independent balance, settlement ruble and other accounts in banks, may have a seal with its name, has the right to have a letterhead with its name, as well as a flag, stamps, emblem, pennant and other symbols, which are established in accordance with the procedure established by the legislation of the Republic of Belarus and this Charter.

1.8. The PA "Professional Dance League" may create business entities.

1.9. The PA "Professional Dance League" maintains record keeping, has an archive and undertakes to hand over documents subject to long-term storage to the institutions of the National Archives of the Republic of Belarus.

1.10. Record keeping, accounting and statistical reporting in the PA "Professional Dance League" are carried out in accordance with the legislation of the Republic of Belarus.

CHAPTER 2

GOALS, OBJECTIVES, SUBJECT AND METHODS OF ACTIVITY OF THE PA " PROFESSIONAL DANCE LEAGUE "

2.1. The objectives of the PA "Professional Dance League" are:

coordination of efforts aimed at promoting the development of all types of dance art and dance sport, as well as choreography in all its directions on the principles of the rule of law, patriotism, moral, aesthetic and spiritual values;

Assistance in the development of cultural, sports and educational relations, both within the country and abroad, with organizations and individuals in a similar field of activity;

organization and holding of festivals, contests, competitions, cups of dance and choreographic art, sports competitions in various types of dance sport, congresses, seminars, round tables, lectures, master classes, etc., independently or jointly with state and (or) public organizations;

Increasing the role of physical culture and sports in the harmonious development of the individual, a healthy lifestyle, the formation of high moral morality, patriotism and love for the Motherland.

2.2. In order to achieve the statutory goals, the PA "Professional Dance League" solves the following tasks:

involvement of citizens, children and youth, as well as the broad masses of the population of the Republic of Belarus in the systematic study and practice of any kind of dance art and dance sport, as well as choreography in all its directions;

Promotion of dances, choreography and sports as a means of aesthetic and physical education, social formation and all-round development of children, adolescents and young people;

Studying and disseminating the best practices of leading teams and teachers;

organization and holding of seminars, conferences, sports camps, etc., including international ones, in order to improve the professional skills of coaches, referees and other specialists, as well as to improve the sports and professional training of dancers and (or) athletes, in order to create conditions for the disclosure of sports and creative capabilities of members of the PA "Professional Dance League";

Improvement of the system of training of athletes and (or) dancers (teams of athletes), ensuring their successful performance at competitions, creating conditions for the fullest disclosure of the potential of their sports capabilities;

Careful preservation of documentary and historical materials about the development of the dance movement in the Republic of Belarus;

Promotion of the principles of fair fight against the use of all forms of doping in sport.

2.3. The subject of activity of the PA "Professional Dance League" is:

The process of development and improvement of all types of dance art and dance sport, as well as choreography in all its directions in the Republic of Belarus;

Organization and holding of events aimed at the development of all types of dance art and dance sport, as well as choreography in all its directions in the Republic of Belarus.

2.4. The PA "Professional Dance League" achieves the implementation of the statutory goals and objectives by all methods permitted by the legislation of the Republic of Belarus:

Development, approval and implementation of the program for the development of dance sports and dance art within the framework of the activities of the PA "Professional Dance League";

organization and holding of sports and mass sports events in dance art and (or) dance sport on the territory of the Republic of Belarus, including republican and international competitions, championships, championships, drawings, cups and other events, including in accordance with the rules for holding competitions in the territory of the Republic of Belarus;

Development and approval of regulations on holding competitions and (or) other events in dance art and (or) dance sport, control over their implementation;

Representation and protection of the rights and legally protected interests of the members of the PA "Professional Dance League" in state bodies and other organizations;

strengthening international cooperation in the field of culture, physical culture and sports, the field of education for the development of all types of dance art and dance sport, as well as choreography in all its directions;

Working with sponsors, receiving donations, sponsorship and other assistance in accordance with the procedure established by the legislation of the Republic of Belarus;

Establishment and development of relations with the media.

2.5. The activities of the PA "Professional Dance League" are:

Cultural and educational, educational, physical culture and recreational, sports and leisure activities;

Holding and organizing sports and (or) cultural, mass sports events and (or) participation in them;

Comprehensive training of athletes (teams of athletes) and their representation at competitions;

Educational and methodological support;

Scientific, methodological and medical support;

Recognition and maintenance of anti-doping and procedural rules;

Strengthening the positions and increasing the prestige of Belarusian dance sport and dance art in the international arena;

participation in the process of selection, placement of coaches and other specialists, improvement of their qualifications, in the training of dancers - athletes of high class;

Sending athletes, coaches, referees and other specialists to participate in events provided for by the calendars of international dance organizations;

Reception of foreign specialists and sending abroad representatives of the PA "Professional Dance League" to solve issues related to its activities;

Nominating athletes, coaches and other specialists to encourage or impose disciplinary sanctions in accordance with the established procedure;

Carrying out other activities in accordance with the legislation of the Republic of Belarus and this Charter.

2.6. In order to achieve the statutory goals and objectives of the PA "Professional Dance League" has the right to:

to carry out entrepreneurial activity in accordance with the established procedure only insofar as it is necessary for its statutory purposes, for which it was created, corresponds to these goals and corresponds to the subject of activity of the PA "Professional Dance League". Such activities can be carried out by the PA "Professional Dance League" only through the formation of commercial organizations and (or) participation in them, unless otherwise established by legislative acts.

CHAPTER 3

TERRITORY OF DISTRIBUTION OF THE ACTIVITIES OF THE PA "PROFESSIONAL DANCE LEAGUE"

3.1. The PA "Professional Dance League" is a local integral public association without organizational structures and carries out its activities throughout the territory of the Republic of Belarus.

3.2. The PA "Professional Dance League" carries out its activities both independently and in close cooperation with educational, cultural, physical culture and sports organizations, other legal entities whose activities are aimed at the development and popularization of dance art and dance sports.

CHAPTER 4

CONDITIONS AND PROCEDURE FOR ACQUIRING AND LOSING MEMBERSHIP, RIGHTS AND OBLIGATIONS OF MEMBERS.

4.1. Members of the PA "Professional Dance League" can be:
citizens of the Republic of Belarus, foreign citizens and stateless persons permanently residing in the territory of the Republic of Belarus and having reached the age of sixteen, taking part in the implementation of the statutory goals and objectives, recognizing this Charter, engaged in activities related to dance art and dance sport, as well as any other types of choreography or contributing to their development and popularization;

Citizens under the age of sixteen, with the appropriate written consent of their legal representatives.

4.2. The PA "Professional Dance League" provides for fixed membership of individuals. Decisions on admission to the membership of the PA "Professional Dance League" are made by the Presidium of the PA "Professional Dance League" on the basis of a written application of the applicant.

4.3. Members of the PA "Professional Dance League" pay entrance and membership fees.

4.4. The procedure and terms of payment, the amount of admission and membership fees are approved by the Presidium of the PA "Professional Dance League".

4.5. The amount of entrance and annual membership fees, benefits, etc. is determined by the Presidium of the PA "Professional Dance League" and is established for a period of one year.

4.6. The entry fee must be paid no later than 30 days from the date of admission to the membership of the PA "Professional Dance League".

4.7. On the basis of an application, a member of the PA "Professional Dance League" may be given a membership card, which is a document

confirming his authority as a member. The sketch of the membership card is approved by the Presidium of the PA "Professional Dance League".

4.8. Members of the PA "Professional Dance League" participate in the activities of the organization, have equal rights and bear equal obligations.

4.9. Registration of members of the PA "Professional Dance League" is carried out by the Presidium of the PA "Professional Dance League".

4.10. Personal data is stored on paper and (or) in the form of computer files.

4.11. Personal data of the members of the PA "Professional Dance League" are collected only to the extent that is necessary for their accounting and use within the statutory activities of the PA "Professional Dance League" and meets the requirements that ensure the active participation of members of the PA "Professional Dance League" in the activities of the public association.

4.12. The use of data about members in the conditions of the activities of the PA "Professional Dance League" is consistent with the legislation of the Republic of Belarus.

4.13. Membership in the PA "Professional Dance League" is terminated in the following cases:

Withdrawal from the PA "Professional Dance League" at their own request;
expulsion from the PA "Professional Dance League" for gross violation of the Charter of the PA "Professional Dance League" and systematic evasion of participation in the work of the PA "Professional Dance League";
in case of death of a member of the PA "Professional Dance League".

4.14. Exclusion and registration of withdrawal from the membership of the PA "Professional Dance League" is carried out by the Presidium of the PA "Professional Dance League" from the date specified in the written application, or from the date specified in the decision of the relevant body.

4.15. The decision on exclusion may be appealed within a month to the higher body of the PA "Professional Dance League". After a year, the expelled person can be readmitted as a member of the PA "Professional Dance League" on a general basis.

CHAPTER 5 RIGHTS AND OBLIGATIONS OF MEMBERS OF THE PA "PROFESSIONAL DANCE LEAGUE".

5.1. A member of the PA "Professional Dance League" has the right to:
receive information from the elected and governing bodies of the PA "Professional Dance League" about the activities of the organization and its bodies, get acquainted with accounting, protocol and other documentation;
appeal against the decision of the elected and governing bodies of the PA "Professional Dance League", entailing civil consequences in the cases and in the manner provided for by the legislation of the Republic of Belarus;

Seek help from the PA "Professional Dance League" to protect their legitimate interests;

On an equal footing with other members of the PA "Professional Dance League" to use the services provided by it;

Take part in the events of the PA "Professional Dance League";

To elect and, upon reaching the age of majority, to be elected to elective bodies;

Receive information about planned and ongoing activities;

To be present at the discussion of any issue concerning personal rights and obligations, to submit complaints and objections to the relevant bodies of the PA "Professional Dance League";

To the protection by the PA "Professional Dance League" of their rights and legitimate interests in state, economic and public bodies and organizations, international sports organizations;

to use in accordance with the established procedure the material, technical, educational and publishing bases of the PA "Professional Dance League" and other property, as well as consulting services in accordance with the law;

To make suggestions regarding the activities of the PA "Professional Dance League";

Free withdrawal from the members of the PA "Professional Dance League".

5.2. Honorary membership is provided in the PA "Professional Dance League". The title "Honorary Member of the Public Association "Professional Dance League" is awarded by the Conference of the PA "Professional Dance League" in relation to members who have made a significant contribution to the development of the dance or choreographic movement in the Republic of Belarus.

5.3. A member of the PA "Professional Dance League" is obliged to:

Comply with the requirements of this Charter, as well as moral principles and ethical standards;

Execute the decisions of the elected bodies and officials of the PA "Professional Dance League";

Actively participate in solving the problems facing the PA "Professional Dance League";

to take the initiative to improve the activities and increase the authority of the PA "Professional Dance League", to protect and multiply the material and technical base;

Pay admission and membership fees in a timely manner;

to take care of the property of the PA "Professional Dance League", not to commit actions that cause material damage to the PA "Professional Dance League" or harm its business reputation.

5.4. For active participation in the activities of the PA "Professional Dance League", significant success in competitions, achievement in the implementation of the statutory goals and objectives, a member of the PA "Professional Dance League" can be awarded awards and incentives. The procedure and types of awards and incentives of the PA "Professional Dance League" are determined by the Presidium of the PA "Professional Dance League". Decisions on encouragement and awarding of members are made by the Presidium of the PA "Professional Dance League".

CHAPTER 6 PROCEDURES FOR THE MANAGEMENT OF ACTIVITIES, STRUCTURE AND ELECTED BODIES PA "PROFESSIONAL DANCE LEAGUE"

6.1. The structure of the PA "Professional Dance League" includes:

The Conference is the supreme body of the PA "Professional Dance League";

The Presidium is a permanent governing body of the PA "Professional Dance League";

Audit Commission – the control and auditing body of the PA "Professional Dance League";

6.2. The supreme body of the PA "Professional Dance League" is the Conference, convened by the decision of the Presidium at least once every four years. The Conference is chaired by the Chairman of the PA "Professional Dance League" or another person elected by the Conference.

6.3. An Extraordinary Conference shall be convened if it is necessary to make decisions within the competence of the Conference:

by decision of the Presidium;

by decision of the Audit Commission;

at the request of at least 1/3 of the members of the PA "Professional Dance League".

6.4. An Extraordinary Conference shall be convened no later than 30 days from the date of the decision of the relevant body.

6.5. The competence of the Conference includes:

Approval of the name and the Charter, making amendments and (or) additions to it;

determination of the number of members and election of the Presidium and the Audit Commission for a period of 4 years, as well as early termination of their powers;

Approval of the report of the Chairman, the Audit Commission for the reporting period;

Determination of priority areas of activity, principles of formation and use of the organization's property;

Determination of current and long-term programs of activities;

Resolves the issue of awarding the title of "Honorary Member" of the PA "Professional Dance League";

Makes other decisions that are binding on all bodies and members of the PA "Professional Dance League".

6.6. The Conference is considered competent if it is attended by at least 2/3 of the delegates from the total number of elected delegates, in accordance with the established quotas the procedure for electing delegates and the norms of representation at the conference are determined by the Presidium. The right to vote is vested in delegates elected by the meetings of members in accordance with the minutes submitted.

6.7. Members of the elective bodies are present at the Conference with the right of a decisive vote and are not included in the number of 2/3 of the required number of delegates for the competence of the conference.

6.8. Decisions of the Conference are made by open or secret ballot by a simple majority of votes of the delegates present at the Conference.

6.9. The Conference has the right to consider any issues introduced by the Presidium, the Auditing Commission, the Board of Trustees or members of the PA "Professional Dance League", if it does not contradict the Charter, and to make decisions on them.

6.10. Information on the convocation of the next conference, the agenda, date, time and place of its holding is announced no later than 30 calendar days before its holding.

6.11. The method of notifying the members of the PA "Professional Dance League" about the upcoming Conference, information about the form of its holding is determined by the Presidium.

6.12. Protocols on the election of delegates should be provided no later than 7 days before the date of the Conference.

6.13. By the decision of the Presidium, the Conference may be held via videoconference using modern communication technologies.

6.14. In the period between conferences, the management of activities is carried out by the Presidium of the PA "Professional Dance League", which:

Decides to convene the Conference;

makes amendments and (or) additions to the Charter of the PA "Professional Dance League" related to the change of legal address or due to changes in legislation;

Elects from among its members the Chairman of the PA "Professional Dance League", Vice-Chairmen;

Makes a decision on admission to membership, exclusion from membership of the PA "Professional Dance League";

Initiate, if necessary, the establishment of the Board of Trustees;

Determines the form and method of keeping records of the members of the PA "Professional Dance League";

Takes measures to create and develop the material and technical base of the PA "Professional Dance League" to ensure its statutory activities;

Makes decisions on the acquisition, disposal and alienation of the property of the PA "Professional Dance League";

Forms the staff of the PA "Professional Dance League", approves the estimate of income and expenses;

Determines the amount of admission, membership and other fees;

Approves samples of seals, stamps, letterheads and symbols of the PA "Professional Dance League";

Makes decisions on the form of holding meetings of the supreme and elective bodies (open, closed), as well as on holding meetings of the supreme and elective bodies via videoconference;

Considers other issues of the activities of the PA "Professional Dance League", except for those that are within the exclusive competence of the Conference;

6.15. All decisions of the meetings of the Presidium shall be recorded in minutes. The decision of the Presidium shall be considered adopted if at least half of the members of the Presidium present at the meeting vote for it. In case of equality of votes, the vote of the Chairman shall be decisive. Voting shall be considered open, unless otherwise decided by the Presidium.

6.16. The Presidium consists of the Chairperson and Vice-Chairmen ex officio.

6.17. Meetings of the Presidium of the PA "Professional Dance League" are held by the decision of the Chairman of the PA "Professional Dance League", on the initiative of at least half of the total number of members of the Presidium or by the decision of the Auditing Commission.

6.18. Meetings of the Presidium are held by the Chairman (or by one of his deputies on his behalf) as necessary, but not less than once every 3 months and are considered competent if at least 2/3 of the members of the Presidium were present at the meeting. Members of the Presidium shall be informed of the convocation of the next meeting at least 5 working days in advance.

6.19. Commissions, committees, councils in various areas of activity may be established under the Presidium. The number of commissions, committees, councils and their regulations shall be approved by the Presidium.

6.20. An Executive Committee may be established to resolve issues of organizational and executive nature and financial and economic activities. The number of members of the Executive Committee shall be determined by the Bureau. The Executive Committee organizes the implementation of decisions of

the Conference and the Presidium, conducts financial and economic activities, and performs other functions delegated to it by the Presidium.

6.21. The Chairman of the PA "Professional Dance League" (hereinafter referred to as the Chairman) has all the rights and performs the duties of the head of the legal entity:

Represents the interests of the PA "Professional Dance League" in state authorities and administration, public associations and other organizations;

Opens settlement (current) and other accounts in banks, issues powers of attorney;

Disposes of the property of the PA "Professional Dance League" within the limits established by the Presidium;

Independently concludes agreements (contracts), hires and dismisses full-time employees of the PA "Professional Dance League";

Issues orders, instructions;

Distributes responsibilities between the Vice-Chairmen and members of the Presidium, chairs the meetings of the Presidium;

Perform any other actions necessary for the achievement of the statutory goals and the fulfillment of tasks, except for those which, in accordance with this Charter, fall within the competence of the Conference and the Presidium.

6.22. The Chairman is accountable to the Conference. In his absence, one of the Vice-Presidents shall preside on his behalf.

6.23. Vice-Chairmen participate in the organization of the activities of the PA "Professional Dance League" within their competence in accordance with the areas of work assigned to them.

6.24. The Auditing Commission of the PA "Professional Dance League":

Monitors the compliance of the PA "Professional Dance League" with the legislation of the Republic of Belarus and the provisions of the Charter;

Carries out an internal audit of the financial and economic activities of the PA "Professional Dance League".

6.25. Members of the Auditing Commission may take part in the work of the elected bodies of the PA "Professional Dance League" with the right of deliberative vote.

6.26. Inspections, audits and meetings of the Auditing Commission shall be carried out as necessary, but at least once a year.

6.27. A meeting of the Auditing Commission shall be deemed competent if more than half of its members are present. Decisions are made by open voting by a simple majority of votes of the present members of the Audit Commission.

6.28. The Audit Commission is accountable to the Conference in its activities. The requirements of the Audit Commission related to the statutory activities are mandatory for all members of the PA "Professional Dance League".

6.29. It is not allowed for a member of the PA "Professional Dance League" to hold positions in the governing and control and auditing bodies of the PA "Professional Dance League" at the same time.

6.30. Decisions of the collegial bodies of the PA "Professional Dance League" are documented in minutes. The Audit Commission draws up inspections in the form of acts and certificates.

CHAPTER 7 PROCEDURE FOR APPEALING AGAINST DECISIONS OF BODIES PA "PROFESSIONAL DANCE LEAGUE"

7.1 Decisions of management bodies and officials are appealed to the Auditing Commission of the PA "Professional Dance League" and are considered in accordance with the Law of the Republic of Belarus "On Appeals of Citizens and Legal Entities".

7.2. Decisions of the Auditing Commission of the PA "Professional Dance League" are appealed to the Conference of the PA "Professional Dance League".

CHAPTER 8 CASH AND OTHER PROPERTY, ECONOMIC ACTIVITY PA "PROFESSIONAL DANCE LEAGUE"

8.1. The PA "Professional Dance League" may own any property necessary to ensure its statutory activities, with the exception of objects that, according to the law, can only be owned by the state.

8.2. The PA "Professional Dance League" carries out the possession, use and disposal of the property in its ownership.

8.3. Property, including funds of the PA "Professional Dance League" is formed from:

Entrance and membership fees;

Voluntary donations from individuals and legal entities;

Deductions made by legal entities, sponsors;

Income from lectures, seminars, sports and other events held for statutory purposes;

Other sources not prohibited by law.

8.4. Funds and other property of the PA "Professional Dance League" cannot be redistributed among the members of the PA "Professional Dance League" and are used only for the fulfillment of the statutory goals and objectives.

8.5. The PA "Professional Dance League" is responsible for its obligations with all the property belonging to the PA "Professional Dance League", which in accordance with the legislation of the Republic of Belarus can be foreclosed.

8.6. The PA "Professional Dance League" may carry out entrepreneurial activities in accordance with the established procedure, only insofar as it is necessary to achieve the statutory goals and objectives and corresponds to these goals and objectives, and corresponds to the subject of activity of the PA "Professional Dance League". Entrepreneurial activity can be carried out by the PA "Professional Dance League" only through the formation of commercial organizations and or participation in them, unless otherwise established by legislative acts.

8.7. The PA "Professional Dance League" has the right to acquire property intended for economic activity, to use its funds and property for charitable purposes.

8.8. Funds and other property of the PA "Professional Dance League" are used to ensure the statutory activities, including:

Creation and development of the material and technical base of the PA "Professional Dance League";

Conducting administrative and economic activities of the PA "Professional Dance League";

Covering the costs of holding festivals, competitions, sports events, lectures, seminars, educational and methodological, sports gatherings;

Financial incentives for members of the PA "Professional Dance League", winners and prize-winners of festivals, competitions, dance projects and sports events;

Payment of salaries, bonuses and other incentives to full-time employees of the PA "Professional Dance League";

Payment of financial assistance to members of the PA "Professional Dance League";

Publication of educational, methodological, informational and other materials;

Entrance and annual membership fees, voluntary donations are non-refundable.

8.9. PA "Professional Dance League" is not responsible for the obligations of its members. Members of the PA "Professional Dance League" are not responsible for the obligations of the PA "Professional Dance League".

8.10. The Presidium of the PA "Professional Dance League" is authorized to make decisions on the formation of funds, other property, as well as their disposal.

BOARD OF TRUSTEES

9.1. In order to assist in ensuring the activities of the PA "Professional Dance League" and the implementation of the statutory goals and objectives, a Board of Trustees (Council) may be established on the initiative of the Presidium of the PA " Professional Dance League ".

9.2. The direct decision on the establishment of the Board is made by the members of the Board at their first meeting. The Council of the PA "Professional Dance League" is an advisory body. The Council may include individuals and representatives of legal entities, including representatives of state bodies, local self-government bodies and others.

9.3. In its activity, the Board is guided by legislative acts, its regulations approved by the Chairman of the Board, and this Charter.

9.4. The Board elects the Chairman of the Board, his deputy and the Secretary.

9.5. The Board is convened by its Chairman, in his absence - by the Deputy Chairman. A proposal to convene the Council may be made to the Chairman of the Council by his deputy, members of the Council, as well as by the Chairman of the PA "Professional Dance League".

9.6. Meetings of the Board are held as necessary, but at least once every 6 months and are authorized to make decisions if at least half of the members of the Board are present at its meeting.

9.7. Decisions of the Board are made by a simple majority of votes of the members of the Board present at the meeting, and are documented in the minutes. The competence of the Council is determined by the legislation and its regulations

CHAPTER 10

PROCEDURE FOR REORGANIZATION OR LIQUIDATION PA "PROFESSIONAL DANCE LEAGUE"

10.1. Liquidation of the PA "Professional Dance League" is carried out:
by the decision of the Conference of the PA "Professional Dance League",
if more than 2/3 of the present delegates voted for this decision;
by court decision, in cases provided for by legislative acts.

10.2. The reorganization of the PA "Professional Dance League" is carried out by the decision of the Conference in the manner prescribed by law, if more than 2/3 of the present delegates voted for this decision.

10.3. Funds and other property of the PA "Professional Dance League" remaining after satisfaction of creditors' claims, by the decision of the liquidation commission, are directed to the statutory purposes of the PA "Professional Dance League".

10.4. Documentation defined by the legislation shall be deposited in the relevant institutions of the National Archives.
